# "Ganjier Free Complete My Journey Pathway Giveaway"

#### Official Rules

## **Eligibility:**

- a. The Ganjier Free Certification Pathway Giveaway (the "Giveaway") is open to legal residents of the United States who are 18 years of age or older at the time of entry.
  - b. Employees, officers, and directors of Ganjier and its affiliates, subsidiaries, advertising and promotion agencies, and immediate family members (spouse, parents, siblings, and children) and household members of each are not eligible to participate.

## **Sponsor:**

## **Agreement to Official Rules:**

### Winner Selection:

- a. The winner will be selected in a random drawing from all eligible entries received during the Entry Period. The drawing will be conducted by the Sponsor or its designated representatives.
  - b. The odds of winning depend on the number of eligible entries received.

## Prize:

## **Publicity Release:**

a. By participating in the Giveaway, the winner grants the Sponsor permission to use their name, likeness, and entry for advertising and promotional purposes without additional compensation, unless prohibited by law.

#### **General Conditions:**
